Point No. 4	First Aid Measure Remove the victim to fresh air area, provide oxygen if required. Remove contaminated clothes from body and wash affected area of body with plenty of water. Wash eyes with plenty of water for 15 minutes. Seek medical aid.
Point No. 5	Fire Fighting Measure Fire – slight fire hazard. Keep containers cool by spraying water if exposed to heat or flame. Unusual hazards :- vapours are invisible spread along the ground. Shut off leaks if without risk, absorb on sand or earth. Disperse & flush. Workers involved in clean up must use protection against skin-contact & respirator tract.
Point No. 6	Accidental Release Measures Fire – slight fire hazard. Keep containers cool by spraying water if exposed to heat or flame. Unusual hazards :- vapours are invisible spread along the ground. Shut off leaks if without risk, absorb on sand or earth. Disperse & flush. Workers involved in clean up must use protection against skin-contact & respirator tract.
Point No. 7	Handling and storage Transferring by hand using open bucket is not recommended because spillage is almost unavoidable. Avoid physical contact, use PPE, store in a cool dry well ventilated location, away from heat. A separated covered storage area should be provided for drums. Drums/ barrels should be air tight, leak proof, direct sunlight should be avoided during transportation.
